#### DIRECT CREMATION (\$395.00 – 840.00)

Our charge for direct cremation without any attendant rites or ceremonies includes basic services of funeral director and staff, filing of official documents, transfer of remains to funeral home, refrigeration and transfer of remains to crematory. State and local laws do not require a casket for cremation. If you wish to arrange a direct cremation, you may use an alternate container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The alternative containers we provide are constructed out of cardboard. Packages do not include medical examiner fee of \$15.00 or sales tax on merchandise.
